The meeting was called to order at 5:30 pm.

The Pledge of Allegiance was recited.

A motion to approve the November 2023 meeting minutes was made by Tom Fuller, seconded by Julie Napier, and the motion was carried.

Additional expenses – Flying S for row markers for cemetery for \$750.00; Crawford County Highway Dept. for Aluminum culverts and signs for \$3,133 and \$454.45 respectively; Wabash Valley Heat and Gas for propane for \$460.00 and \$573.28; NAPA for an oil filter for \$69.98; Burkees for Stocking Cap for \$13.00, and Midwest Tractor Repair for air filter and another filter for \$37.75 and \$108.00 respectively. A motion made by Alan Fulling to approve the November 2023 expenditures, seconded by Tom Fuller and the motion was carried.

New Business

A motion was made to approve the road name of “George Fulling Drive” on the new road south of the ball diamond by Julie Napier, seconded by Tom Fuller and the motion was carried. Shawn Elder will check with Justin Childress on how to get this done.

Fred McNair raised some issues found at the new cemetery while placing the new row markers. There are three (3) monuments that will need to be adjusted in their placement and the east road will need to be moved more to the west.

Clerk Report:

Brigetta Brannon informed the Board that the website has had the setup fee processed and the website is “in the queue” and should be available for our customization within the next couple of weeks.

Cemetery Report:

Rodney Bond distributed the schedule for the Trustees to complete checks on the cemeteries during the off-mowing season.

Road Commissioner Report

Shawn Elder picked up the new truck. He is currently working on decals to place on the trucks. Shawn also asked to give a Christmas bonus to John. A motion was made by Alan Fulling to give John a \$200 Christmas bonus, seconded by Rodney Bond and the motion was carried.

Trustee Report:

Fred McNair made a motion to give Mary Guyer a \$100 Christmas, seconded by Tom Fuller and the motion was carried.

Julie Napier noted that the flagpole in the East Union Cemetery needs repainting when the season allows.

Rodney Bond announced that the Board will need to begin working on the mowing contract bid in January/February 2024.

A motion to close the meeting was made by Tom Fuller, seconded by Alan Fulling and the motion was carried.
